#### **Submissions**

Conference organisers seek to attract research of the highest scholarly quality in the fields of law and finance related to private equity (PE) and venture capital (VC), broadly defined, to be presented at the Conference. While the focus is on PE and VC, submissions addressing related aspects of private markets more generally are also of interest.

Submissions of papers that would benefit from multidisciplinary and practitioner input are particularly welcomed. The organisers aim to foster a collegial community of scholars with a strong interest in PE/VC, across career stages and disciplines.

We invite researchers to submit either:

(1) a working paper that will not yet be published at the time of the Conference

#### OR

(2) an earlier-stage research project in the form of an extended abstract.

The organisers will select papers and discussants from among distinguished practitioners, industry representatives, policymakers, and scholars from finance, economics, and law. Authors of accepted submissions will receive a notification by the end of March 2026 and will be asked for prompt confirmation of their participation.
